





- To form Managing Committee/s of the schools, colleges and other institution whatsoever of its kind by this trust, to supervise or to vi) manage the respective such institute or conduct specified jobs or functions in such manner and subject to such rules and regulations as the trustees may prescribe.
- The Trustees shall cause true and accurate accounts to be kept of all moneys received and spent and of all matters in respect thereof in course of management of Trust properties or in relation to the carrying out of the objects and purpose of the Trust as well as of all the assets, credits and effects of the Trust properties.






